THE CHAOS OF ILLEGAL IMMIGRATION

Michelle Malkin has recently written a great new book, *Open Borders Inc: Who's Funding America's Destruction?* The following statistics she gives are quite shocking:

Number of foreign-born individuals in the U.S.: 44.5 million (1 in every 7.3 people or 13.7 percent of the population; the highest in 107 years.)

Annual number of new green cards issued: 1.1 million

Estimated number of illegal aliens in the U.S.: 11 million-17 million to 22.8 million-30 million

Illegal aliens granted Obama DACA protection from deportation and work permits: 800,000

Estimated number of illegal visa overstayers in the U.S.: 4.5 million-6 million

Estimated annual cost of illegal immigration to taxpayers (local, state, and federal): \$16 billion-\$54 billion

Number of people smuggled across Mexico to southern U.S. border every year: 800,000

Annual revenue from southern border smuggling enterprise: \$3.7 billion-\$4.2 billion

Total number of illegal unaccompanied alien children (UAC) served in HHS tax-subsidized shelters: 340,000

Annual budget for HHS illegal alien children's housing (2017): \$1.4 billion

The cost of illegal immigration to American citizens is just as high, if not higher, than it is to the illegals that come here. Americans bear the cost of illegal immigration by the children who are brought here by their illegal alien parents who do not speak English and cannot read or write even in their own language. These children flood our schools and educational institutions which must hire teachers for these children. Americans bear the cost of illegal immigration when poor illegal aliens who have no money and no medical insurance flood our hospitals and emergency rooms. Americans bear the cost of welfare services and benefits to people who are not citizens of our country and have not paid into Social Security and Medicare for years as have American citizens.

Paul Bedard is an excellent investigative journalist. One of his recent articles published by *The Washington Examiner* highlights the real cost Americans pay for the estimated 14.3 million illegal aliens in our country.

[Federation of American Immigration Reform], which annually tabulates the fiscal price for illegal immigration, put a price of \$130 billion on the crisis this year. Costs for federal, state, and local governments range from security, to free healthcare, and education of undocumented immigrants.

And if its 2025 calculation of 21 million illegals were to come true, FAIR predicted a cost of \$200 billion . . . In coming up with its calculation of the U.S. illegal immigrant population, FAIR used U.S. Census Bureau data and made adjustments for the "undercount" of those who do not participate in government surveys (Paul Bedard, "Surge: 14.3 Million Illegal Immigrants in US Costing Taxpayers \$130B," *The Washington Examiner*, September 23, 2019.

The pro-open borders crowd who want our country to give carte blanche permission to every person in the entire world to live in the United States never reveal how Americans are supposed to continue to financially support with their tax dollars people who have no right to be in our country. The same groups and politicians who demonize anyone against illegals flooding our country have no sympathy for Americans who have been murdered by illegal aliens and their loved ones who mourn for them

every day. Americans also bear the cost of American lives destroyed by the drugs pouring across our border.

Illegal immigration is dramatically changing our country. In the first two centuries of our country's history, immigrants were expected to adopt, embrace, and accept the United States Constitution, language, culture, society, and traditions. In a speech to the American Defense Society in 1919, former U.S. President Theodore Roosevelt made these comments on immigration ten years after he left the office of the presidency.

In the first place we should insist that if the immigrant who comes here in good faith becomes an American and assimilates himself to us, he shall be treated on an exact equality with everyone else, for it is an outrage to discriminate against any such man because of creed, or birthplace, or origin. But this is predicated upon the man's becoming in very fact an American, and nothing but an American . . .

There can be no divided allegiance here. Any man who says he is an American, but something else also, isn't an American at all. We have room for but one flag, the American flag, and this excludes the red flag, which symbolizes all wars against liberty and civilization, just as much as it excludes any foreign flag of a nation to which we are hostile . . . We have room for but one language here, and that is the English language . . . we have room for but one sole loyalty and that is a loyalty to the American people.

This is not what is happening in our country in the 21st century. Immigrants are no longer assimilating and becoming Americans. In fact, they are encouraged by our politicians to NOT assimilate. They are encouraged to keep their allegiances to their former countries, as well as their language, culture, and traditions and are praised and applauded for doing so. In fact, our pro-illegal alien politicians feel that illegals are more American than Americans born and raised in the United States.

Nancy Pelosi, the current speaker of the House of Representatives, is only one of our politicians who have promoted, championed, and praised illegal immigrants living in the United States. She made the following remarks about illegal aliens on November 12, 2019 titled on her website "Pelosi Remarks at Bicameral Press Event on Supreme Court Oral Arguments in DACA Case."

It seems that Nancy Pelosi is more grateful for the illegals in our country than the legal American citizens who work hard, raise their families, pay taxes - taxes which are used to educate and take care of the same illegals she praises.

Below are just a few examples of how illegals have impacted and influenced our country.

For instance, in 2010, five students attending the Live Oak High School in Morgan Hill, California, wore American flag T-shirts on Cinco de Mayo day. The school principle sent the boys home from school when the boys refused to turn their t-shirts inside out because he said the shirts were

Incidents like these in schools across our country were preceded by the protests and demonstrations on May 1, 2006. Instead of staying in the shadows, illegal aliens across the United States decided they were being so mistreated and maligned by Americans that thousands boldly paraded down streets in major cities all across our country, demanding their "rights" in a country they came to illegally.

In "Immigrants Stage Protests Across U.S." by Maria Newman, published on May 1, 2006, by *The New York Times*, here is what some of the people, including illegal aliens who participated in the protests and marches, had to say.

"We deserve what we're asking for," said Francisco Bear, 60, one of the demonstrators in Chicago, who came to this country in 1968 and became a citizen and now owns a truck leasing business. "We love America and we're workers." . . .

"We are telling people that this will be an educational experience for their children to learn more about civil rights and also to increase awareness of social issues," said Ricardo Ortega, a community organizer for the group El Comite Pro-Amnesia General y Justica Social. "Hopefully the next generation will be concerned about justice for everybody."

People toted signs that read "Who will pick your fields and build your houses? Who will pick your tomatoes?"

The crowd shouted in Spanish: "We are here and we aren't leaving!" . . .

Among the demonstrators was Leonardo Hernandez, 24 a construction worker and computer science student at Miami-Dade College Homestead Campus, who is also president of the student government.

"I am undocumented, and even after I graduate, I won't be able to find a job," Mr. Hernandez said. "My father is a citizen, but I arrived 10 years ago and I applied then but it'll be another year until they process mine."



Victor Davis Hanson

Victor Davis Hanson, one of the premier historians in the United States today, has written extensively about the illegal immigration problem in California. His excellent book, *Mexifornia*, which I cited above, is unfortunately no longer in print. But City Journal Magazine published one of Hanson's articles about how illegal immigration which describes how the state of California has dramatically changed in just a few short decades. What Hanson reports on should scare every American citizen.

Thousands arrive illegally from Mexico into California each year - and the state is now home to fully 40 percent of America's immigrants, legal and illegal. They come in such numbers because a tacit alliance of Right and Left has created an open-borders policy, aimed at keeping wage labor cheap and social problems ever fresh . . . The tragedy is that though illegal aliens come here hoping to succeed, most get no preparation for California's competitive culture. Instead, their activist shepherds herd them into ethnic enclaves, where inexorably they congeal into an underclass. The concept of multiculturalism is the force-multiplier that produces this result: it transforms a stubborn problem of assimilation into a social calamity . . .

[U]nlawful immigration has become the third rail of California politics. Even to discuss the issue can earn politicians the cheap slander of "racist" or "nativist" . . . Californians cannot even obtain accurate numbers of how many of the state's more than 10 million Hispanic residents have arrived here from Mexico unlawfully in the last two decades. No one believes the government's old insistence on a mere 6 million illegal residents nationwide: the real figure may be twice that. The U.S. Hispanic population - of which over 70 percent are from Mexico - grew 53 percent during the 1980s, and then rose another 27 percent to a total of 30 million between 1990 and 1996. At present rates of births and immigration, by 2050 there will be 97 million Hispanics, one-quarter of the American population.

... Liberal economists swear that legal immigrants to American bring in \$25 billion in net revenue annually. More skeptical statisticians . . . conclude that aliens cost the United States over \$40 billion a year, and that here in California each illegal immigrant will take \$50,000 in services from the state beyond what he will contribute in taxes during his lifetime . . .

My sleepy hometown of Selma, California, is in the dead center of all this. The once rural San Joaquin Valley community has grown from 7,000 to nearly 20,000 in a mere two decades, as a result of mostly illegal immigration from Mexico. Selma is now somewhere between 60 and 90 percent Hispanic. How many are U.S. citizens is either not known or not publicly disclosed: but of all those admitted legally from Mexico to the United States since 1982, only 20 percent had become citizens by 1997. Some local schools, like the one I went to two miles from our farm, are 90 percent first generation Mexican immigrants. At the service station a mile away, I rarely hear English spoken; almost every car that pulls in displays a Mexican flag decal pasted somewhere . . .

I used to worry over the theft of a tractor battery. Yet in the last decade, I have run off at gunpoint three gang members trying to force their way into our house at 3 a.m. Last year, four patrol cars - accompanied by a helicopter whirling overhead - chased drug dealers in hot pursuit through our driveway. One suspect escaped and turned up two hours later hiding behind a hedge on our lawn . . . When a carload of thieves tried to steal oranges from our yard, I soon found myself outmanned and outgunned - and decided that 100 pounds of pilfered fruit is not worth your life (Victor Davis Hanson, "Do We Want Mexifornia?" City Journal, Springs 2002, https://www.city-journal.org/html/do-we-want-mexifornia-12236.html, accessed December 15, 2019).

Ignacio Ramos and Jose Compean

One of the most heinous miscarriages of justice that highlights the chaos illegal immigration has brought to our country is the plight of Ignacio Ramos and Jose Compean. Ignacio Ramos and Jose Compean were two Border Patrol agents. On February 17, 2005, Ramos and Compean were patrolling the border near El Paso, Texas when they saw drug smuggler Osvaldo Aldrete Davila, trying to cross back into Mexico from Texas with 743 pounds of marijuana. Believing Davila to be armed and dangerous, the agents opened fire, hitting Davila in the buttocks. Davila made it back to Mexico but then filed a complaint against the two border agents.

Johnny Sutton, the U.S. Attorney for the Western District of Texas, disputed the account given by the two border agents and believed the illegal drug smuggler, who insisted that he was unarmed at the time of the incident.

Yes, you read this right. A U.S. government attorney took the word of an illegal alien drug smuggler over the account of two American border patrol agents.

The Bush Administration gave Davila, an illegal alien drug smuggler, full immunity to testify against Ramos and Compean, a "humanitarian" visa to allow the Davila to travel between U.S. and Mexico easier, as well as using U.S. taxpayer dollars to provide medical care to Davila for free for his injuries due to the shooting.

Unfortunately, Ramos and Compean were convicted and sentenced to prison. They admitted they had not reported the incident because they didn't think they had injured Davila, but according to the Border Patrol bureau's rules, Ramos and Compean should have been suspended for 5 days for not reporting the contact with Davila and the shooting. Instead, Ramos and Compean were slapped with 11-year and 12-year prison sentences. President George Bush eventually commuted their sentences and they were released in March 2009. President George Bush commuted their sentences on his last day in office but it is a tragedy when two American citizens, doing their jobs to protect the United States of America, are sentenced to prison unjustly. This is just another part of the chaos that illegal immigration has brought our country.

SANCTUARY STATES, SANCTUARY VOTERS

One of the more dangerous trends fueling the illegal immigration crisis in the United States is the declaration of some cities and even states that they are sanctuaries for illegals. These cities and states refuse to comply with federal law regarding illegal immigration and refuse to turn illegal aliens over to federal officials.

According to the Daily Caller:

The spate of improper registrations was the second major statewide error at the California DMV in the last two months. The agency admitted in early September that it had mishandled about 23,000 voter registrations by assigning them to the wrong political party or mislabeling vote-by-mail preferences (Dan Cadman, "California DMV on Improperly Registering License Applicants, Including Aliens, to Vote: Oops!, "Center for Immigration Studies, October 11, 2018, https://cis.org/Cadman/California-DMV-Improperly-Registering-License-Applicants-Including-Aliens-Vote-Oops, accessed December 15, 2019).

When you hear Democrat politicians demanding that "every vote must be counted," this is what they mean. They do not want any vote to be declared ineligible, including those by dead people, cartoon characters, people registered in different counties and states at the same time, and illegal aliens.

California is not the only state skirting our election laws by issuing driver's licenses to illegals. Colorado, Hawaii, Vermont, New Mexico, Maryland, Illinois, Delaware, Washington, Nevada, Connecticut, and now New York are all on board the driver's license pathway to vote for illegals train. It's only because illegals are promised massive social benefits - benefits that should only belong to American citizens - by Democrat Party politicians that this is occurring. Other pro-illegal immigration groups that push voting for illegals include La Raza, El Republica Del Norte supported by Dr. Charles Truxillo, adjunct professor at the University of New Mexico, and George Soros' Open Society Foundations. Soros especially has poured millions of dollars into the United States to overthrow our Constitution and government through promoting an open borders agenda.

I promise you, if illegals voted along conservative principles, these heavily liberal and progressive states would never allow this.

By the way, if you think I'm being too harsh in my criticism of illegals in our country, consider Mexico's constitution in respect to foreigners.

Article 33. Foreigners are those who do not possess the qualifications set forth in Article 30 . . . the Federal Executive shall have the exclusive power to compel any foreigner whose remaining he may deem inexpedient to abandon the national territory immediately and without the necessity of previous legal action.

Foreigners may not in any way participate in the political affairs of the country. (emphasis mine, https://www.oas.org/juridico/mla/en/mex/en mex-int-text-const.pdf, accessed December 9, 2019).

This means that Americans in Mexico are not allowed to participate in public protests, demonstrations, or criticisms of the government of Mexico like the illegals in our country are allowed to do today. This includes being prohibited from voting in elections, as well.
