THE WUHAN CORONAVIRUS IN BIBLE PROPHECY

HOW THE CCP BIO-WEAPON IS ADVANCING WORLD GOVERNMENT

Since early this year, the “Covid-19 Pandemic” has been the leading news story around the world. In this article, I will deal with the question as to how this pandemic fits into Bible prophecy. As such, I will seek to tell the truth, as best I know it, regardless of what you may be hearing in the Main Stream Media. I will also seek to be forthcoming as to how this “emergency” is contributing to the Anti-Christ system of global control predicted in the Bible.

We begin with a prediction Jesus made in the Olivet Discourse in answer to his disciples’ question, “. . . And what will be the sign of Your coming, and of the end of the age?” (Matthew 24:3 - NKJV throughout). The answer to that question deals with many signs (events) that will portend His Second Coming. We read in verse 7: “For nation will rise against nation, and kingdom against kingdom. And there will be famines, pestilences, and earthquakes in various places.” Webster defines “pestilences” as “. . . any virulent or fatal contagious or infectious disease, especially one of epidemic proportions.”

It is probable that, at the time of Christ’s predictions, contagious diseases of epidemic proportions did not exist. However, as we approach the Tribulation and the Second Coming, contagious diseases of

epidemic proportions now exist. For example, the world experienced the Spanish Flu, which killed approximately 50 million people about a century ago.

Another prophecy relevant to the current pandemic is found in Daniel 7:23: “. . . The fourth beast shall be a fourth kingdom on earth, Which shall be different from all other kingdoms, And shall devour the whole earth, Trample it and break it in pieces.” Daniel is predicting, in his vision of four great beasts (Daniel 7:15-28) that the final beast or kingdom will be worldwide in its scope and unlimited in its power.

Obviously, this coming worldwide kingdom, under the control of the antichrist, will also include the United States. How does America transform from a Constitutional Republic with limited, defined governmental power into a totalitarian government that has been merged into a global government? In my view, this will be through a series of strategic “emergency crises.” The Wuhan coronavirus is one of those crises.

Rahm Immanuel, former chief of staff of President Obama, famously said, “You never let a serious crisis go to waste. And what I mean by that it’s an opportunity to do things you think you could not do before.” Immanuel first made that statement during the financial crisis of 2008. He recently repeated that statement, referring to the Wuhan crisis.

James Clyburn (D-SC) made a similar statement in regard to the Economic Stimulus bill passed in March. “The (Economic Stimulus bill) is a tremendous opportunity to restructure things to fit our vision.”

Thomas Paine, famous Revolutionary era author, stated presciently: “Liberty is never more at risk than during a crisis.”

For example, look at all the Liberty-reducing changes that came about as a result of the 9-11 crisis: The Patriot Act, The National Defense Authorization Acts, the Department of Homeland Security, the TSA, Secret FISA Courts, etc. These changes are never going away! When the government takes your liberties, they are *never* relaxed.

Likewise, the changes I will be describing in this article will never go away unless there is massive citizen resistance! The changes being implemented as a result of the Wuhan coronavirus pandemic are quickly becoming the “new normal.” I predict that the masks, gloves, thermometers and social distancing will *never go away!* Friends, this unbearable, Orwellian world is the “new normal.”

THE ORIGINS OF THE WUHAN CORONAVIRUS



It is important to emphasize at the outset that this is a *manufactured crisis*. In other words, contrary to the propaganda of the Chinese Communist Party (CCP), this virus did not emerge, by accident, from the Wuhan wet markets. The truth is that this virus was created in the Wuhan Virology Institute lab, with assistance in the United States during the Obama administration. It is the *CCP Coronavirus!*

Let me quote from a March 22, 2020 *World Net Daily* article by Lt. Col. James Zumwalt entitled, “Whose fingerprints are on the coronavirus?”

“As the coronavirus took global flight, Dr. Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases at the National Institutes of Health, made a startling revelation. He warned it is at least 10 times deadlier than the seasonal flu. But it is biological warfare (BW) expert professor Francis Boyle’s interview that details what may we have led to coronavirus having such a powerful punch.

“Boyle explains the concept of ‘gain of function.’ This is work that involves activating genetic mutations to more strongly enhance their impact. In layman’s terms, it is the equivalent of placing a virus on steroids. He details evidence as to how it may well have come into play to increase the lethality of the virus. As China and the U.S. play the blame game as to who is responsible for the pandemic, Boyle names names, explaining that several different sets of fingerprints were involved.

“The BW expert is clear at the outset that there is little doubt the coronavirus now touring the globe came out of China’s biowarfare lab in Wuhan. Regardless of what the Chinese government says in its efforts to cloud the issue to focus responsibility elsewhere and regardless of assertions by American liberals we are racist for calling it such, *the release* of coronavirus bears a ‘made in China’ stamp. However, Boyle’s investigation also reveals that others linked to various stages of development of the virus must share some responsibility as well.

“Boyle tells us he has definite evidence a biowarfare lab at the University of North Carolina (UNC) was the initial catalyst for the virus. He had criticized the lab earlier for its ‘gain of function’ work. He condemns UNC for its DNA genetic engineering ‘on every hideous biological warfare agent you can imagine, including MERS (Middle East Respiratory Syndrome), an agent which, again, is a bio-warfare coronavirus.’ In the interview Boyle read from a study underscoring that the UNC lab project

had discovered: ‘A SARS-like cluster of circulating bat coronaviruses shows potential for human emergence.’

“Shockingly, the study noted involvement in the project not only by UNC researchers and FDA representatives but also by ‘Zhengle-Li Shi, Key Laboratory of Special Pathogens and Biosafety, Wuhan Institute of Virology, Chinese Academy of Sciences, Wuhan, China.’ Acknowledging the National Natural Science Foundation of China at the study’s end made it clear the coronavirus technology was not stolen by China but Beijing had paid UNC to have one of its top BW experts involved in the project.”

THE PREDICTION OF THE WUHAN CORONAVIRUS

While this Plandemic took most of the world’s citizens by surprise, it did not surprise the globalist elites who had “war-gamed” this scenario many years before. In May of 2010, the Rockefeller Foundation, along with the Global Business Network (GBN) published “Scenarios for the Future of Technology and International Development” which used game theory to map out different scenarios that both reduced and enslaved the world’s population, all under the guise of helping solve hypotheticals. Let’s consider one of their hypothetical scenarios.

In one scenario, called *LOCK STEP*, they set forth one possible scenario:

“In 2012, the pandemic that the world had been anticipating for years finally hit. Unlike 2009’s H1N1, this new influenza strain - originating from wild geese - was extremely virulent and deadly. Even the most pandemic-prepared nations were quickly overwhelmed when the virus streaked around the world, infecting nearly 20 percent of the global population and killing 8 million in just seven months, the majority of them healthy young adults. This pandemic also had a deadly effect on economics: international mobility of both people and goods screeched to a halt, debilitating industries like tourism and breaking global supply chains. Even locally, normally bustling shops and office buildings sat empty for months, devoid of both employees and customers.

“During the pandemic, national leaders around the world flexed their authority and imposed airtight rules and restrictions, from the mandatory wearing of face masks to body temperature checks at the entries to communal spaces like train stations and supermarkets. Even after the pandemic faded, this more authoritarian control and oversight of citizens and their activities stuck and even intensified” (“LOCK STEP: The Rockefeller Foundation’s 2010 Plan To Enslave the World Using Future ‘Plandemic,’” Haley Kennington, April 18, 2020, toresays.com).

THE IMPACTS OF THE WUHAN CORONAVIRUS

The impacts of this Plandemic are as staged and artificial as the origin of the virus. Consider, for example, the recent global concert promoting the “COVID culture.” Let me quote from an article published by the *Vigilant Citizen* on April 24, 2020 entitled, “‘Together At Home’ was an Infomercial for the Global Elite and its Agenda.”



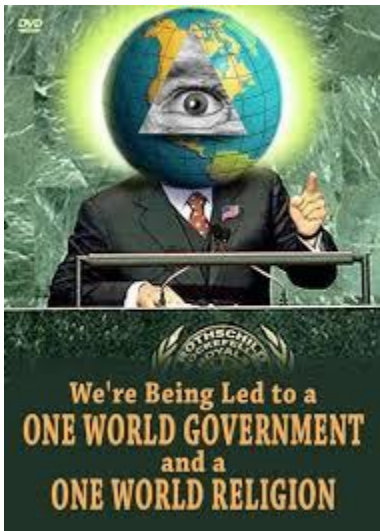
“*Together At Home* was more than a ‘virtual concert’. It was a show of force. It was broadcast everywhere, on all TV stations and on all streaming platforms. That fact alone was a strong indication of the sheer power behind this event. Furthermore, the list of celebrities and powerful people who appeared during that event was simply staggering with headliners such as Lady Gaga, Billie Eilish, Taylor Swift, and Celine Dion. However, this event was not only about music. The music was there to attract people. Between the performances, there were specific messages coming from powerful places . . .

“The most obvious (and annoying) aspect of *Together At Home* was its celebration of a ‘COVID culture’. Indeed, in the past weeks, we’ve seen media doing its best to normalize a world where confinement, isolation, and video conferencing were the new norm. While social distancing is supposed to be an extreme (and very temporary) emergency measure to prevent the spread of a deadly disease, *Together At Home* appears to be promoting it as a long-term way of life.

“And, to prove that ‘it is not so bad’, the usage of video conferencing is constantly promoted for everything. In the sad world that is presented in *Together At Home*, all aspects of life - including arts, family, business and education - can be fulfilled through video conferencing. In their new world, human connections depend on an internet connection. Maybe they want all human communications to be recorded . . . and monitored.”

THE IMPLICATIONS OF THE WUHAN CORONAVIRUS

There are several implications or transformations of this Plandemic that relate to Bible prophecy. Due to the space limitations of this article, I would like to deal with three of those world transformations:



WORLD GOVERNMENT: The Bible predicts that, during the Tribulation, a world government, economy and religion will come to fruition under the leadership of the False Prophet and The Antichrist (see Revelation 13 & 17). While these Satanic developments are hindered during the Church Age (see 2 Thessalonians 2:6-8), it is plausible to think that progress will be made in that direction during the last days of the church age.

How, then, is progress made toward a one-world government and all that it entails? It will be through a series of strategic and managed crises of a global nature. After all, the “experts” tell us that a global crisis requires a global response!

Consider, for example, a March 26, 2020 article by Larry Elliott in *The Guardian* entitled, "Gordon Brown calls for global government to tackle coronavirus."

"Gordon Brown has urged world leaders to create a temporary form of global government to tackle the twin medical and economic crises caused by the Covid-19 pandemic.

"The former Labour-prime minister, who was at the centre of the international efforts to tackle the impact of the near-meltdown of the banks in 2008, said there was a need for a taskforce involving world leaders, health experts and the heads of the international organisations that would have executive powers to coordinate the response . . . 'This is not something that can be dealt with in one country,' he said. 'There has to be a coordinated global response.'"

I am reminded of the words of a bygone world leader who spoke in similar fashion. Paul-Henri Spaak, the first president of the United Nations General Assembly, said: "We do not want another committee. We have too many already. What we want is a man of sufficient stature to hold the allegiance of all the people and to lift us up out of the economic morass into which we are sinking. Send us such a man and, be he god or devil, we will receive him."

The day is coming when the whole world will cry out, in desperation, for such a man, and this Plandemic brings us one step closer to that day. The Bible says that, ". . . The coming of the lawless one is according to the working of Satan, with all powers, signs, and lying wonders, and with all unrighteous deception among those who perish, because they did not receive the love of the truth, that they might be saved" (2 Thessalonians 2:9, 10).



DIGITAL DOLLAR: The Bible predicts that, when global government comes to a brief fruition at the mid-point of the Tribulation, that the antichrist will activate a comprehensive and global cashless society. We read in Revelation 13:16, 17: "He (the Antichrist) causes all, both small and great, rich and poor, free and slave, to receive a mark on their right hand or on their foreheads, and that no one may buy or sell except one who has the mark or the name of the beast, or the number of his name."

There has been much speculation regarding the nature of the mark of the beast. Some say it is some kind of digital tattoo on the surface of the hand or forehead. Others speculate that it may be some kind of microchip that is preloaded like some kind of debit card. Regardless, all agree that this coming economic system involves the elimination of cash, whether paper or coinage. It is interesting that the current Plandemic is moving that cashless society agenda forward.

Consider the following article written by Gina Heeb of *Business Insider* on November 20, 2019, entitled, “The Federal Reserve is looking into developing a digital currency in the US, Powell Confirms”

“US central bankers have explored the possibility of developing a digital currency that would be directly available to businesses and household, Federal Reserve Chairman Jerome Powell confirmed to lawmakers this week.

“While we are not currently developing a central bank digital currency, we have assessed and we continue to carefully analyze the costs and benefits of pursuing such an initiative in the U.S.”

“A digital currency backed by the central bank in the largest economy could be unprecedented and raise a host of legal and operational questions. Powell said it would be closely considered by policymakers but added that the US could be in some ways better positioned than other countries that have looked into such a proposal.”

What was considered just a few months ago as “unprecedented and raising a host of legal and operational questions” is now being reconsidered in light of the Wuhan Plandemic.

Consider an April 20, 2020 article by Gina Jurva of the *Legal Executive Institute* entitled, “Will COVID-19 Make Cash Obsolete?”

“Is the COVID-19 pandemic more quickly moving the world to a cashless society? One where almost all financial transactions are not conducted with physical banknotes or coins, but rather through the transfer of digital information via a smartphone?”

“Thompson Reuters technologist and futurist Joe Raczynski explains why cash may no longer be king and how the fear of banknotes carrying and passing the coronavirus itself may help get us there more immediately . . .

“**Joe Raczynski:** Sooner than we thought, we will be moving away from the possibility of literal *dirty money*, meaning legal cash tender. Believe it or not, the United States was on the cusp of issuing a digital dollar . . . at the end of March. As part of the early draft for the COVID-19 stimulus package, bold and powerful policy makers vied for the creation of a Digital Dollar.”



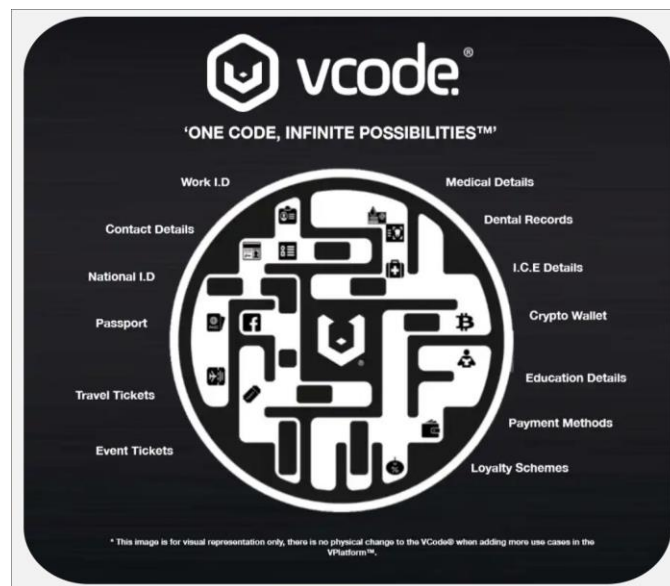
THE MARK OF THE BEAST: The Wuhan Plandemic is also moving forward the idea of an international digital tattoo, a precursor to the mark of the beast. Infamous eugenicist Bill Gates is

championing this technology. Quoting from a March 19, 2020 article that appeared in *Biohackinfo.News* titled, “Bill Gates will use microchip implants to fight coronavirus”:

“Microsoft co-founder Bill Gates will launch human-implantable capsules that have ‘digital certificates’ which can show who has been tested for the coronavirus and who has been vaccinated against it Gates was responding to a question on how businesses will be able to operate while maintaining social distancing, and said that, ‘Eventually we will have some digital certificates to show who has recovered or been tested recently or when we have a vaccine who has received it.’

“The ‘digital certificates’ Gates was referring to are human-implantable ‘QUANTUM-DOT TATTOOS’ that researchers at MIT and Rice University are working on as a way to hold vaccination records The quantum-dot tattoos involve applying dissolvable sugar-based microneedles that contain a vaccine and fluorescent copper-based ‘quantum dots’ embedded inside biocompatible, micron-scale capsules. After the microneedles dissolve under the skin, they leave the encapsulated quantum dots whose patterns can be read to identify the vaccine that was administered.”

While the quantum-dot tattoos may not be ready for rollout in America just yet, it appears that the United Kingdom is a bit further along in their mark of the beast prototype technology.



Consider the May 26, 2020 *Infowars.com* article by Jamie White entitled, “COVI-PASS: UK INTRODUCES DIGITAL HEALTH PASSPORT TO MONITOR TRAVEL, HEALTH OF POPULATION”

“The UK government is preparing to rollout a new ‘digital health passport’ to monitor nearly every aspect of citizens’ lives in the name of strengthening public health management.

“British cybersecurity firm VST Enterprises, in partnership with the UK government, developed an application called ‘COVI-PASS’ to track ‘your Covid-19 history and immunoresponse and other relevant health information’ using a proprietary matrix code called a ‘VCode’ . . .

“The ‘VCode’ itself is described as an end-all tech that can store every sensitive detail about your life using military-grade encryption software.” LOVELY!

CONCLUSION

The Antichrist system of global control over the political, economic and religious system will not drop out of the sky at the mid-point of the Tribulation. Rather, it will be developed incrementally, with each successive engineered crisis. The Wuhan coronavirus Plandemic illustrates that the night is far advanced and the day of our redemption draws near.

As Jesus said in Luke 21:25-28: “And there will be signs in the sun, in the moon, and in the stars, and on the earth distress of nations, with perplexity, the sea and the waves roaring; men’s hearts failing them from fear and the expectation of those things which are coming on the earth, for the powers of the heavens will be shaken.
