The D.C. Jail - the New Dachau

I had the grim experience of visiting the Dachau Concentration Camp near Munich in 2011. I learned several things during the extensive tour of the facility. It was the first concentration camp built by Nazi Germany, opened on March 22, 1933. The camp was initially intended to intern Hitler's political opponents, which consisted of communists, social democrats and other dissidents such as journalists.

The Dachau prisoners were not criminals in the traditional sense of the word. They were not guilty of robbing, destroying property, raping or killing. Instead, they were "guilty" of the "political crime" of opposing the Nazi regime. The humiliation and torture of these political prisoners was unspeakable. First, they were marched through the little town of Dachau so they could be publicly humiliated. Then, they were marched through the entrance gate which carried the phrase "*Arbeit macht frei*" (lit. "Work shall set you free").

As the 20 or so prisoners were assembled just inside the gate, an SS Officer randomly chose one of the prisoners and brutally beat him to a pulp. This was to send a message to the others. Then they were marched into a room, stripped naked and clothed in prison uniforms. On the wall was a mocking sign in German which said “no smoking.”

For the duration of their time at Dachau (usually two years for dissidents) prisoners lived in constant fear of brutal treatment and terror detention including standing cells, flogging and pole hanging. For those who survived, they were released with strict instructions not to tell others about their treatment at Dachau. They were also under orders to report to Gestapo headquarters twice a day. It was in this manner that Hitler broke the back of the NAZI resistance in Germany.

So effective was the Nazi method of removing the enemies of the Reich to Dachau that as early as 1935 a jingle went around: “*Lieber Herr Gott, mach mich stumm, Das ich nicht nah Dachau komm*” (“Dear Lord God, make me dumb [silent], That I may not to Dachau come”).

In retrospect, it is amazing how quickly the Hitler regime conquered and subdued the German people. Hitler became Chancellor of Germany after the elections in November, 1932, but his Nazi Party had not won an overall majority. He therefore obtained Cabinet consent to hold new elections on March 5,

1933. Meanwhile, his propaganda minister, Joseph Goebbels, devised the scheme whereby ten Nazi agents were to gain access to the Reichstag (parliament building) through a tunnel leading from the official residence of Hermann Goring, Reichstag president and Hitler's chief minister.

The Nazis burned the Reichstag in Berlin on February 27, 1933, a key event in the establishment of the Nazi dictatorship, in a false flag event designed to turn public opinion against its opponents and to assume emergency powers.

On February 28, 1933, the day after the fire, Hitler's dictatorship began with the enactment of a decree "for the Protection of the People and State," which dispensed with all constitutional protection of political, personal, and property rights. Though the ensuing elections still did not give the Nazis an outright majority, they were able to persuade the Reichstag to pass an *Enabling Act* (March 23, 1933) whereby all its legislative powers were transferred to the Reich Cabinet by a vote of 444 to 94, so sanctioning the dictatorship.

The day before the passage of the *Enabling Act*, on March 22, 1933, the Dachau Concentration Camp was opened to intern Hitler's political opponents. The camp was opened by Heinrich Himmler, one of the leaders of the Reichstag fire staged event. Dachau's close proximity to Munich, where Hitler came to power and where the Nazi Party had its official headquarters, made Dachau a convenient location. From 1933 to 1938, the prisoners were mainly German nationals detained for political reasons.

After the German people were subdued by the persecution and imprisonment of dissidents, Hitler turned his deadly focus on the Jews. Kristallnacht (German: "Crystal Night") took place on November 9-10, 1938. The name *Kristallnacht* refers ironically to the litter of broken glass left in the streets as a result of Nazi violence against Jews throughout Germany. As a result of the shooting of a German diplomat by a Polish-Jewish student, Hitler ordered the Gestapo chief Heinrich Muller to send a telegram to all police units informing them that "in shortest order, actions against Jews and especially their synagogues will take place in all of Germany."

In two days and nights, more than 1,000 synagogues were burned or otherwise damaged. Rioters ransacked and looted about 7,500 Jewish businesses, killed at least 91 Jews, and vandalized Jewish hospitals, homes, school and cemeteries. Some 30,000 Jewish males aged 16 to 60 were arrested and 10,000 of these Jews were interned at Dachau. As the German military occupied other European states, citizens from across Europe were imprisoned at Dachau. When the war was drawing to a close in early 1945, the crematoriums at Dachau were burning 24 hours a day as the Nazis feverishly sought to kill all of their prisoners before the allies could free them. Through the efforts of courageous American troops Dachau was liberated on April 29, 1945, rescuing the surviving 30,000 prisoners.

Dachau was the concentration camp that was in operation the longest, from March 1933 to April 1945, nearly all twelve years of the Nazi regime. It is estimated that Dachau Concentration Camp housed over 188,000 inmates during this period, of which 41,500 were murdered.

THE DEMOCRAT MODEL

Someone has said, "History does not repeat itself; it merely rhymes." Let's take an openminded look at the "rhymes" being perpetrated by the Biden regime in the short period of their power since January 2021.

On November 3, 2020 the Biden campaign stole the presidential election by deeply rigging six counties in six swing states. This was followed by several protests in Washington D.C. culminating in a massive protest that occurred on Wednesday, January 6, 2021, the day the election was to be certified by Congress. There were several FBI and Capitol Police officers in MAGA gear mixed into the crowd, provoking violence and facilitating entrance into the capitol. Though the Biden administration labeled January 6 as an insurrection, it was more properly a *FEDSURRECTION*. January 6 was the Democrat's "Reichstag fire."

Shortly after this event, the FBI began rounding up January 6 patriots, prosecuting them and placing them in the D.C. Department of Corrections Central Detention Facility. Many have been incarcerated for years, still waiting to have their cases adjudicated. Thus far, over 1,000 people have been incarcerated for the *Fedsurrection*. As many as an additional 2,000 American patriots are being pursued by the F.B.I. You may visit the following F.B.I. website where these "fugitives of justice" are pictured (www.fbi.gov). By the way, this website has a "tipline" so you can rat out your neighbors and facilitate their arrest.

The J6 investigation has been a massive undertaking, both in its scope and cost. Every U.S. Attorney's office has been involved, as well as every FBI field office. So far 2.6 billion dollars has been allocated to the U.S. Attorneys (not counting the cost of the FBI investigations), in support of the January 6 prosecutions.

The defendants - who came from nearly all 50 states - are a tough group to generalize. Most of them appear to be white men. About 15% of the defendants have a background in the military or law enforcement.

There seems to be a special effort to convict leaders of patriot groups. For example, Stewart Rhodes, founder of the Oath Keepers, was sentenced to 18 years in prison. Staff Sergeant Joe Biggs, another leader of the Oath Keepers, was also sentenced to 18 years in prison. Enrique Terrio, leader of the Proud Boys, was sentenced to 22 years in prison, even though he was not in Washington, D.C. on January 6.

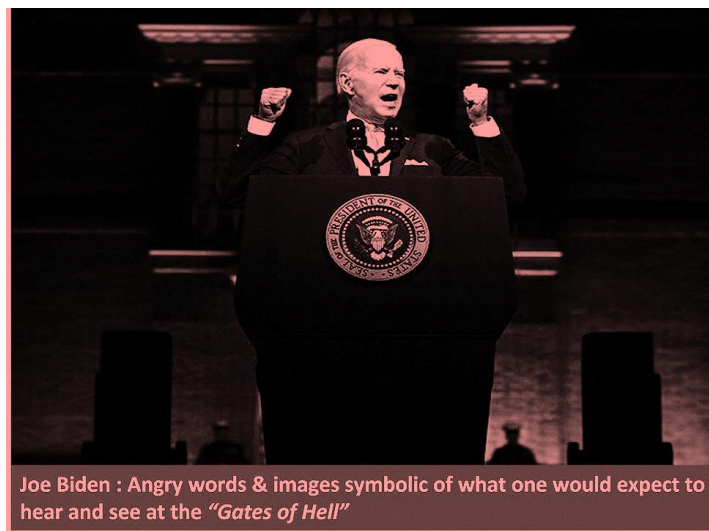
Journalists also have been targeted. For example, Owen Shroyer, a reporter for *Infowars*, was recently sentenced to 60 days in prison for the "crime" of believing the 2020 election was stolen. Shroyer never entered the Capitol and discouraged others from entering as well. He was also

recently hit with a bill for \$300,000 from the IRS. Could it be that the alphabet agencies of the Federal leviathan are working together against American patriots?

Conditions for J6 political prisoners in the D.C. jail are atrocious. In a seven-page letter submitted to a federal court and signed by 34 defendants, they listed several issues. “The conditions allegedly include no religious services or visitation, black mold and worms on the jail’s walls and in food, abuse by guards, and vaccine requirements for visits and others services. They also say their clothing sent to laundry is returned covered in brown stains, pubic hair and reeking of ripe urine. And they say they’ve lost eyesight and hair because of malnourishment” (www.npr.org/2022/10/07).

There have also been at least three J6 defendants that have committed suicide rather than face the prospect of incarceration in the D.C. jail. These individuals are Matthew Perna, Mark Aungst and Christopher Georgia. This is in addition to Trump supporters who were murdered by Capitol police on January 6, 2021. Ashli Babbett was shot at point blank range by officer Michael Byrd. Rosanne Boyland was beaten to death by a baton by a female officer (whose name has been scrubbed from the internet).

BROADENING PERSECUTION OF PATRIOTIC AMERICANS

Joe Biden declared war on the 74 million plus American citizens that voted for Donald Trump in 2020 in his September 2, 2022 “Gates of Hell speech.” Quoting selectively from his speech, the usurper declared, “Donald Trump and the MAGA Republicans represent an extremism that threatens the very foundations of our republic . . . I am reminded of a speech Adolf Hitler gave at the Reichstag in 1939 where he threatened the annihilation of the Jewish race in Europe in the event of war: “If international finance Jewry inside and outside Europe should succeed in plunging the nations once more into a world war, the result will be not the Bolshevisation of the earth and thereby the victory of Jewry, but the annihilation of the Jewish race in Europe.”

Friends, in Biden’s America, we are the “new Jews!” Joe Biden did not waste any time following through on his declaration of war against patriotic Americans. On September 23, 2022, Catholic pro-life activist Mark Houck was at his home at 6:45 a.m. when 20-plus F.B.I. agents and state troopers started banging on his front door. He said the FBI repeatedly rang the doorbell and banged on the door saying “open up!” After they identified themselves, he opened the door and showed them his hands. “As I opened the door, I could not believe the circus scene that I saw. By this time, his wife and seven children were awake and standing in their living room. There were at least five FBI agents on the porch with M-16s pointed at Mark and his children. He was shackled and hauled off to jail for the “crime” of protesting at an abortion clinic. By the way, a jury found him NOT GUILTY of any crime and he is suing the FBI. Good for him!

More recently, Trump supporter Douglas Mackey was handed a seven-month prison sentence for sharing a Twitter meme that Democrats could vote for Hillary by text in 2016. No evidence was presented showing that anyone had been duped by the meme, and the same kinds of messages were sent by anti-Trump Twitter users, without anyone being charged.

President Trump is facing a total of 91 charges in four criminal cases. They include 44 federal charges and 47 state charges, all of them felonies.
